PRESIDENT'S REPORT



It is my great pleasure to present the President's report for the 2020 financial year of the Brisbane and District Ladies' Golf Association (BDLGA). Unlike most years there would be extensive reporting on meetings, issues, and tournaments, but given the unprecedented situation we found ourselves in, almost from the last AGM in March 2020 this has been a quiet year for us. As I sit here writing this report, Greater Brisbane is a three day lock down to try, once again, to retain the spread of the UK strain of the COVID-19 virus. This just proves, we cannot be complacent, and we pray this will only be for three days. However, the news from around the world remains a concern and we take one day at a time.

With the uncertainty and constant changing and modifications to the various health directives, the Management Committee made the decision to cancel all tournaments except for the Sarah Jane Kenyon Challenge held on 1 November 2020. Even though playing golf was recognised as safe during the pandemic, the number of players allowed, the closed clubhouses and subsequently the reduced number of patrons allowed in Clubs made gatherings of any kind prohibitive.

During this time and to enable us to maintain some form of contact with our members, Deb Marsland our Pennant coordinator initiated a COVID-pennant competition and this is reported under the Pennant Report. We thank Deb for her persistence and hard work in the pennant area. But thank heavens for technology and emails. We managed to communicate frequently and have managed to hold four committee and one delegates meeting.

During this time, the management committee seized on the opportunity to upgrade our constitution which is now complete and includes all the changes required by the Associations Incorporations Act which was highlighted to all Clubs by Golf Australia.

Judy Shelton resigned, and we thank her for her years of service and dedication. Renai Ridley has stepped into the role of tournament coordinator and is already making changes to streamline processes and procedures for both tournaments and sponsorships. All tournaments, dates and venues, can be found on the website.

The Sarah Jayne Kenyon challenge was held at Wantima on 1 November 2020. Our sincere thanks to Wantima for their assistance. According to Sue Strong, our Junior coordinator, the girls showed exceptional skill and sportsmanship and in Sue's words "the future of women's golf is in good hands". Reassuring. Thank you, Sue, for your continued commitment to Junior golf. We recognise this as a fundamental part of our charter which will ensure the support of our young golfers and their encouragement to pursue the game of golf.

The annual BDLGA get-away to Kooralbyn was organised, once again, by Deb Marsland. We are currently in negotiation with several courses for the 2021 get away and will provide the detail as and when received. This, from all accounts, is a great weekend and escape for many so we encourage you to diarise this and enjoy time away with your golfing friends. Thank you Deb for your continued assistance with organising this.

We now look forward to 2021 and hopefully manage to try and get some level of normality into the golfing world. We have all missed the camaraderie and sharing with you all at our competitions. We certainly have missed the opportunity to play at different courses and share different experiences.

We thank our sponsors for their continued support of our organisation. Thailand Golf Tours, Tony Hollands Funerals, Vanity Fairways, Jane Holt and Family, Drummond Golf, The Village, we thank you sincerely for providing us with additional funding to ensure a magnificent experience for our members at various competitions and to enable us to supplement our prize offerings.





To the Management Committee, my sincere thanks. You stepped in and stepped up during an exceedingly difficult time and I believe we managed to steer the organisation through this, even with a slightly questionable rudder. I will not be standing as President next year as my commitments as President of McLeod, especially with the uncertainty still surrounding COVID-19 ever increasing.

We encourage you to nominate for a Management Committee position in 2021. There will be a few vacancies and it is important to continue to refresh the knowledge and skills base for the continuity of the organisation.

So my very best to each and every member Club of the BDLGA. We hope you have a successful year and we look forward to your participation in our events throughout 2021.

We have been able to partner with a new major domestic sponsor for 2021 which will make it an exciting season.

PENNANTS

Hopefully 2021 will have better weather conditions and all matches will be played.

It's unfortunate that more clubs don't enter Junior Pennant Teams or form composite teams. There are 125 girls registered in our District as Juniors with handicaps. With the maximum Handicap of GA 32 playing off 3/4 handicap

there must be more than 18 girls capable of playing pennants.

If we can't get Clubs to participate in Pennants, as time goes on there will be no Junior Pennants which would be a pity, as it's not us who are missing out it's the girls.

SARAH JANE KENYON

COVID-19 arrived in March and all competitions were cancelled except for the Sarah Jane Kenyon District Challenge, held in November.

The SJK is played between the Sunshine Coast and Brisbane Districts each year. The teams consist of 8 girls, none of whom have played in the Junior Jug.

This year the Match was played at Wantima, with final result being a draw.

Next year the event will be held on the Sunshine Coast. Date and venue to be confirmed.

JUNIOR CHAMPIONSHIPS

Cancelled for 2020.

In 2021 the Junior Championships will be combined with the Boys.

We believe we can create a Major Junior Event that will attract more players than before making for a more competitive competition.

At this point, it is planned that the Championships will be held on the 8th and 9th July, yet to be confirmed, along with the venue.

September.

Report on the Audit of the Financial

Report Opinion

We have audited the financial report of Brisbane & District Ladies Golf Association Inc. which comprises the assets and liabilities statements as at 31 December 2020, the income and expenditure statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the certification by members of the committee on the annual statements giving a true and fair view of the financial position and performance of the association.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of Brisbane & District Ladies Golf Association Inc as at 31 December 2020 and its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the Queensland Associations Incorporation Act 1981.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110: Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of the Queensland Associations Incorporation Act 1981. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibilities of the Committee for the Financial Report

The committee is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the Queensland Associations Incorporation Act 1981 and for such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the committee is responsible for assessing the association's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the committee either intends to liquidate the association or to cease operations, or has no realistic alternative but to do so.



Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, where due to fraud or error, and to issue and auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but it is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the association's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the committee.
- Conclude on the appropriateness of the committee's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the associations ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the association to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

BRISBANE & DISTRICT LADIES' GOLF ASSOCIATION INC. NOTES TO AND FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDED 31 DECEMBER 2020

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Queensland Associations Incorporation Act 1981. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on a cash basis whereby items are recognised as money is paid or received, as recorded in the records of the Association.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a. Property, Plant & Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciation amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the assets is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

b. Revenue and Other Income

Revenue is measured at the fair value of the consideration received after taking into account any trade discounts and volume rebated allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent to the instrument.

Grant and donation income is recognised when the entity obtains control over the funds which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

NOTE 2: ASSETS & LIABILITIES

The only Assets and Liabilities of the association are those shown in the balance sheet. Further the association has no Mortgages, Charges or Securities of any description.
