President's Report



As 2023 comes to an end we can reflect on a very eventful year for the BDLGA. We started the year farewelling some beloved and experienced representatives and welcomed new management & committee members.

Our Tournament participation was increased this year, but the availability and costs of courses has become a real challenge. The 2024 calendar has our major events planned but we are still waiting on confirmation on a couple of venues.

The talent in our junior players is incredible, with many new players starting to emerge we also see many ageing out of our juniors and into our senior ranks where we are excited to welcome them. It was also wonderful to see many juniors playing in our club pennant teams and I know feedback from junior players is extremely positive with the experience they are getting by their inclusion in this competition. Our juniors have many competitions on offer from a club, school, GN Junior, state and Australian level which makes attendance at some of our team events hard. Scheduling will be our priority moving forward to continue to improve the support of our district Junior members.

The Meg Nunn event for 2023 was postponed and discussions were held on a district and Golf Qld level regarding the future of this event, and also the Men's equivalent tournament, the inter district Matchplay. As they both stood, it was determined without unanimous district support and participation that the events had run their course. At the AGM it was proposed by Golf Qld, after summarising a SWOT analysis at a prior meeting, that it was important that the event be brought in line with Golf Australia's strategic plan of inclusion. Golf Qld have proposed to run a combined District tournament, held annually on the Gold Coast, with teams of 6 of each gender, and a mix of different games, over a 3-day period. The event progression required unanimous support of all districts to proceed. At the time of writing, we are yet to have that result. The BDLGA support an inter district competition that offers the majority of our players the opportunity to represent their district in a competitive team environment - UPdATE Outcome -

Golf Qld also determined at their meeting that the BDLGA, who were previously the only district excluded from Country Week, are now eligible to enter. Details of the conditions of entering into this competition will be available on the entry form and website.

The Pennant season saw a new team format and seemed to work well for the majority of clubs. 2024 will see the same format but with a few tweaks to make it more efficient. The pennant workshops held were invaluable, and I thank all who participated in those discussions. After the 2024 season we will be able to really determine how the new format is working.

The BDLGA Committee Grant program which was created to give back during the Covid Pandemic continued this year. A huge number of clubs applied and unfortunately BDLGA could not fund all applications. We will be assessing the criteria and viability of continuing this program for 2024. With such a large number of clubs seeking assistance, it is important to note that there are many grant and funding opportunities to be applied for with Golf Qld and Golf Australia, especially in the area of





clinics, lessons and introductory programs for junior and senior players. Clubs, Pros and members can access the details of these on the Golf Australia website.

This year saw the first of what will now be an annual Matchplay event, with 12 players from BDLGA challenging a team from the Sunshine Coast. Over two Sundays the trophy is determined and even though this year's title went to the Sunshine Coast we look forward to another challenge in 2024. The team consists of 12 players, 6 Handicapped and 6 off the stick Matchplay. This allows a wide selection of players with differing abilities and handicaps to represent our district. This year's event was a great success.

The BDLGA wishes to thank our generous Sponsors and Golf Clubs who continue to support our District events and in turn support our association and our players. Without them we would find it hard to offer the incredible value tournaments and fabulous prizes presented at our events.

We had a fantastic new location for our annual golf trip this year at Noosa Springs. The event was a success, and it is being continued onto the 2024 calendar.

Thank you to the Management Committee, Delegates & Club Representatives for their hard work and commitment to ensuring that their clubs & the BDLGA had a successful 2023.

Tournament Report



We had a very successful calendar of events this year, with no adverse health or weather events compromising our tournaments. With the increase in green fees, we wouldn't be able to continue to provide affordable entry fees if it weren't for these generous sponsorships. 2024 is looking even more fantastic with many of these sponsors' continued support.

We had a fantastic start to the season with 22 clubs representing BDLGA for the Halcyon Cup. For the second time we walked away with a win for the Teams and the Committee Trophy. So far there is no date for the 2024 Halcyon Cup and with Halcyon no longer fully sponsoring the event, The Gold Coast District is looking into options for its continuation, we will let you know the outcome.

Our season started this year with the District Championships. We had 94 entries from 22 clubs. The Village were this year's sponsors. The weather was very wet to start but fined up and we had many dedicated players compete. It was fantastic to see a few Juniors in the field. A nail biter finish, even up to the last hole, saw our district's very talented Lilli-J Dunn, Redland Bay, win the Champion of Champions and the Div 1 Gross by 1 shot from Oxley's Jess Jenkins. 2024 PENNANT SEASON

After review of the season and all the changes in 2023, no fundamental changes have been made for the 2024 year. There will be a couple of minor amendments to the Pennant Regulations – a team member will not be able to play for any other team and the names of the divisions for Friday and Sunday have been aligned.

The concept of running an off the stick competition for low handicaps was considered, but after consultation, there were insufficient clubs which could field teams to make the competition viable. It has been decided however that the Yellow Diamond divisions will have a sub-competition and a pennant awarded for the team with the most successful group of off the stick players.

Junior Report



Thank you for the opportunity to be the Junior Golf Coordinator again this year.

There are initiatives in place now to look at how to retain junior girls in the game.

Brisbane Junior Amateur Championship was held at Brisbane Golf Club for the 3rd year in a row on the 6th and 7th of July. We had 21 girls compete this year. Numbers will probably stay at this level whilst it clashes with the NSW equivalent. Thanks again to BDGA and especially Warwick Nicol for organising this event and being so inclusive of our district girls. Thanks also to Brisbane Golf Club for allowing the Junior Championship to utilise their course for 2 half days in the school holidays. Best Gross Open winner was Allegra De Guzman from (Pacific) with an amazing 3 under on the first day of competition.

Best Gross Closed winner was Lilli-J Dunn from (Redland Bay).





The Junior Jug team for 2023 was Caitlin Vanderkruk (Keperra), Allegra De Guzman (Pacific) and Mikayla Dyal (Keperra) with Lilli-J Dunn (Redland Bay) as reserve.

The tournament is a stroke event over three days with the best 2 nett scores taken each day to give an overall aggregate best nett result. The Junior Jug Development camp from the 16^{th} - 20^{th} September is held in conjunction with the Katherine Kirk Classic 17th- 20^{th}

September. The camp run by Lee Harrington and Virginia Irwin gave the girls many wonderful opportunities including meeting girls from across the state and listening to the likes of Justice Bossio. Treasurer's Report



The financial report has been prepared on a cash basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Change in year-end in 2022, to align with the Golf Australia, Golf Queensland, Brisbane District Ladies Golf Association (BDLGA) elected and applied to change year end to 30 June.

Financial Audit

The 2023 Financial Statements have been prepared and audited by our appointed auditor, Mr. Robert Warner from Ferrari Warner, Chartered Accountants (CA). The Financial Statements have been certified by the auditor as being true and correct without qualification.

Profit & Loss

The Association Cash Assets as of 30 June 2023 total \$141,618.87. This includes the deposits for Noosa Springs Getaway 2023 held in October 2023.

The statement of Income and Expenditure (Profit & Loss) shows that our main income was from tournaments including competition fees, sponsorship and raffle incomes.

Total profit of the organisation is \$1710.58.

The new Premier Investment account was opened on the 7th December 2022 for a term of 12 months (to be matured in Dec 2023) with \$80,000 balance with an interest rate of 4.00%.

Club Assistance Program

Based on a strong financial position we were able to continue the Club Assistance Program in 2023 which supported 8 clubs for different reasons, ranging from course support after flood damage, to golf lessons to encourage beginner golfers into club membership. Payments are still being made and final payments are to be made within a few weeks.

Financial Statement

I would now like to propose that the 2023 Financial Statements as contained in the Annual Report be accepted.



Our conclusions are based on the audit evidence obtained up to the date *of* our auditor's report. However, future events or conditions may cause the association to cease to continue as a going concern.

Evaluate the overall presentation. structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.




