President's Report

Our juniors have many competitions on offer from a Club, school, GN Junior, State and Australian level which makes attendance to some of our team and events hard.

I would like to thank the parents and guardians of our junior players for their ongoing support in getting our players to lessons, club games, tournaments and for fostering the growth of our future champions.

Golf Australia hosted the Qld District Team Championships at Royal Pines in November. For our District this replaced the Meg Nunn Teams event. Eight (8) female District and 11 male District teams attended the 3-day event on the Gold Coast. The event appears to be a huge success with our ladies' team coming in third and our men's team second. Golf Qld will look at all survey feedback and look to finetuning the event for 2025. Our team selection will be from our Championship results with the Gross and Nett winners of 3 divisions being offered the team positions. Runners up will be reserves. We thank our amazing players - Kylie Jackson, Di Paez, Nicki Stansfield, Amy Kim, Judy Noble and Joanne Meier who did us proud.

The Golf Qld AGM was held after the final District Championship round. We saw **Judy Logan** and **Michelle Stanley** stepping down from their Golf Qld Board positions. With Judy 12-years in the role and Michelle 6-years, we thank them for their support and contribution to lady's golf over the years. We congratulate **Robyn Byrnes** on her appointment to the Golf Qld Board and wish her success in her role of championing women's, men's and District golf into the future.

The 2025 pennant season will see a similar version of the 2024 season with the addition of a higher handicap team. It is the same format but with a few tweaks to make it more efficient. The pennant workshops held during 2024 were invaluable and I thank all who participated in those discussions. We will be hosting another pennant information session prior to the start of the 2025 season to help with system onboarding.

The Interdistrict Matchplay event against the SCBWGA was held for the second year with 12 players from BDLGA. Over 2 Sundays in July the trophy was determined, and it was a nail biter, but we took home this year's title. We look forward to another challenge in 2025.

The team consists of 12 players, 6 handicapped and 6 off the stick Matchplay. This lets us have a wide selection and abilities of players representing our District and it was a great success.

Next year sees us putting together our new Strategic Plan for 2025-2030. This is an exciting time for any organisation. Maroochy Rivers Golf Club from 15 to 17 September 2024. And the **Sarah Jane Kenyon Challenge** scheduled to be played at Redcliffe Golf Club on 3 November 2024, was won on forfeit by our B&D team.

BDLGA sponsored two golfing clinics for our junior girls this year which were held at Pacific Golf Club. We are planning to provide further junior girl golfing clinics in 2025 across our District and will share more detail once we have dates and venues.

Treasurer's Report



The Brisbane and District Ladies Golf Association (BDLGA) Inc. financial report has been prepared on a cash basis and is based on historical costs, modified where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

With the change for year-end reporting in 2022 to align with Golf Australia, Golf Queensland, the BDLGA and the applied changes for financial end of year to 30 June 2024, the reports reflect 2023-2024 for a

full year, with a half year 1 January 2024 to June 2024.

BDLGA continues to be in a strong financial position with continued support via capitation income from Golf Australia and from our members support for our tournaments. This enables us to further support other initiatives including our junior development programs and interdistrict competitions.

Financial Audit

The 2024 Financial Statements have been prepared and audited by our appointed auditor, Mr Robert Warner from Ferrari Warner, Chartered Accountants (CA). The Financial Statements have been certified by the Auditor as being true and correct without qualification.

Profit and Loss

BDLGA cash assets as at 30 June 2024 total \$153,785.50, with breakdown as follows:

Bank of Queensland WebSavings 20373642: \$ 20,352.23
Bank of Queensland Investment Account 23372056: \$ 83,200.00
Total Current Assets: \$153,785.50

The cash assets include deposits for the Noosa Springs Getaway event in October 2024. The profit for the year ended 30 June 2024, was **\$12,395.97**, with the main sources of income from capitation fees and tournaments. Major expenses for the year were tournament fees.

Report on the Audit of the Financial Report

Opinion

We have audited the financial report of Brisbane and District Ladies Golf Association Inc, which comprises the assets and liabilities statements as at 30 June 2024, the income and expenditure statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the certification by members of the committee.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of Brisbane and District Ladies Golf Association Inc as at 30 June 2024 and its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the Queensland Associations Incorporation Act 1981.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 1 10: Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter — Basis of Accounting

We draw attention to Note I to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of the Queensland Associations Incorporation Act 1981. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibilities of the Committee for the Financial Report

The committee is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the Queensland Associations Incorporation Act 1981 and for such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Queensland Associations Incorporation Act 1981. The committee has determined that the association is not a reporting entity.

The financial statements have has been prepared on a cash basis, whereby items are recognised as money is paid or received, as recorded in the records of the Association.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a. Property, Plant & Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciation amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the assets is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

a. Revenue and Other Income

Revenue is measured at the fair value of the consideration received after taking into account any trade discounts and volume rebated allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method.

Grant and donation income is recognised when the entity obtains control over the funds which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

NOTE 2: ASSETS & LIABILITIES

The only Assets and Liabilities of the association are those shown in the balance sheet. Further the association has no Mortgages, Charges or Securities of any description.
