2026 to 2030 BDLGA Strategic Plan

The BDLGA Management Committee established a Working Group (including Cathy Hindmarsh, Ros Eenglund, Lisa Laney and Gillian Di Corleto) to commence work on updating our current 2020 to 2025 BDLGA Strategic Plan following our **September 2024 Management Committee meeting**. Our initial, ambitious idea was to adopt a Plan on a Page format to produce a concise new BDLGA Strategic Plan. The Working Group commenced populating the draft Strategic Plan following the canvassing of members' suggestions at our **December 2024 Delegate Meeting**. A draft was tabled at our **February 2025 Management Committee meeting** covering our key mission themes of **fostering**, **encouraging** and **promoting** women's golf, ensuring we did not lose the best ideas from our current plan while modernising the content to include KPIs and alignment with industry Strategic Plans.

Key to our proposed new Strategic Plan is the importance of keeping BDLGA grassroots focused and making what we offer transparent. Our planned F2F Strategic Planning Working Group meeting did not eventuate following our **July 2025 Management Committee meeting** due to the scope of business on our agenda. However, the Working Group plus other interested and available Management Committee members met at OGC on 20 August 2025 to finalise a draft for endorsement at our **October 2025 Management Committee meeting**.

Next steps involve our proposed new 2026 to 2030 BDLGA Strategic Plan being circulated for member feedback following our October 2025 meeting in advance of anticipated adoption at our **December 2025 Delegate Meeting**.

BDLGA key document review

At our **July 2025 Management Committee meeting**, the following documents including our current **Constitution** (dated January 2021), **By-Laws** and **Honorarium Criteria** (last updated in November 2021) were identified as requiring review and updating. A subgroup including interested and available Management Committee members met at OGC on 20 August 2025 to identify proposed edits to these key documents for consideration by the Management Committee at our **October 2025 meeting**.

Next steps involve sharing of proposed edits to these key documents with our members in advance of **voting** on adoption of changes at our scheduled **AGM in December 2025**.

3) Notes to the Profit and Loss Report for the current Financial Period 1 July 2025 - 31 August 2025

- a) Golf Australia has forwarded the second tranche of capitation fees for 2025, but it is slightly less than 2024.
- b) Noosa Springs expenditures have been finalised for 2025 and a deposit for 2026 has been made. Similarly, income from this event is not showing as most funding/deposits were collected prior to this financial year (2025/26). This is more clearly shown in the Job Profit and Loss report.
- c) More income this year has been received due to an increase in tournaments that have been held in this financial year, with the Blitzer being held for the first time increasing income stream.
- d) The Club Assistance Program, although finalised a year or so ago, was paid to Wantima Golf Club in good faith as they had been given a grant but had not finalised their plan for expenditure. This has now been completed with them supporting new lady golfers with lessons and junior girls with gear.

Pennants Report – October 2025

1. 2026 Structure

The structure for 2026 will fundamentally remain the same as this year with three divisions and two separate competitions on Friday and Sunday. The current three-tiered structure was introduced for the 2025 season with the inclusion of Emerald division.

The divisions for 2026 will be renamed to **Gold**, **Silver** and **Bronze**, following strong support through feedback at the Pennants debrief meeting in July 2025. Depending on the number of competing teams, a division may be divided into zones, which will be determined by the BDLGA Pennant Sub Committee and will be allocated based on the dates nominated by participating Clubs.

Gold Division will have 7 players with the first 3 matches played Off The Stick and the remaining 4 matches played using Full Handicap difference. We will continue to award the pennant for the winning team overall as well as a sub-competition with a pennant awarded for the team with the most successful group of Off The Stick players on both Friday and Sunday. As a way of recognizing the 'elite' players, there will be an additional leaderboard created for the Off The Stick competition which will be displayed in Golf Genius and on the BDLBA website.

Silver Division will have 7 players with all matches played using Full Handicap difference. The GA will remain the same with a maximum GA28 and the minimum aggregate for the team being at least 100, which is an average of GA14.3 per player.

Bronze Division will have 5 players with all matches played using Full Handicap difference. The handicap range is from GA20 to a maximum GA36 with the minimum aggregate for the team being at least 125 which is an average of GA25 per player.

2. Pennant Regulations

The 2026 Pennant Regulations are currently under review by the BDLGA Management Committee. Once complete, a copy will be distributed to all clubs participating in the 2026 Pennant Competition and a copy will be available on the BDLGA website at https://bdlga.com.au/pennants-home

3. Intention to Compete

The Intention to Compete form and letter for the 2026 BDLGA Pennant Competition have been distributed via email to Clubs on **Friday**, **5 September 2025** and is available to download (https://bdlga.com.au/pennants-home) on the BDLGA website. The Intention to Compete forms are to be lodged by **Friday**, **17 October 2025** with the aim of confirming dates with the host venues by early November 2025.

When filling in the Intention to Compete form, we ask that Clubs:

• Nominate as many dates as possible for hosting as this will allow us some flexibility when compiling the draws for each division and zones.

- Provide the cost of carts and approximate number that can be allocated for pennants.
- Advise whether catering will be provided.

4. Golf Genius

Golf Genuis is planning to release updates to the Team Match portal to increase performance for administration operations in late 2025. Phase two of the upgrades will be due for release in early 2026 and will be focused on improving functionality for the Team Captains.

The feedback received at the end of the 2025 season has been passed on to Golf Genius and they are confident most of the points raised can be easily solved. This includes operating the software on tablet and/or phone, accessing leaderboards, improved 'drag and drop' function when moving players to the team list, and configuring result sheets.

A training session will be scheduled in **March 2026** to help team captains set up teams in Golf Genius and go through any changes in the software that affect the competition.
