Pennants were a major event in our calendar this year. Congratulations to the winners of the Divisions and to all players who participated. Full results are listed in this Annual Report.

The Meg Nunn Salver was hosted by the BDLGA this year and was played at McLeod Country Golf Club. It is with great pleasure that the Brisbane and District team won this prestigious Salver which was presented to the team by Anne Brown, Meg Nunn's daughter. The 2018 event will be played at Rockhampton Golf Club.

The national coaching clinic arranged with the Australian Lady Golf Professionals was a huge success and has been scheduled in our 2018 calendar.

The juniors played the Sarah Jane Kenyon Challenge in November against the Sunshine Coast and Burnett District. This was a single matchplay format, and unfortunately our girls went down to Sunshine Coast. Maybe 2018 will be our winning year.

I have attended the Golf Queensland Annual General Meeting in May 2017 and the District Delegate's Forum in December. We should encourage all players to participate in the wide range of events offered by both Golf Queensland and BDLGA. The success of the Brisbane and District is due to the backing of each of you and your clubs.

To all the members of the Management Committee, you have given me your full support and time during the year, thank you.

We will work together again in 2018 to produce another successful year for the Brisbane and District clubs and players.

TOURNAMENT / MATCH REPORT

The Brisbane and District year started with the District Foursomes at McLeod Country Golf Club. We had 59 teams from 16 clubs, compared to 64 teams in 2016. The winners on the day came from Pacific, Keperra, Riverlakes/Wynnum and Mcleod Golf Clubs.

The Junior Championships were held at Virginia Golf Club. This event was held in conjunction with Junior Golf Qld. In 2018 this event will be hosted solely by the BDLGA. Junior numbers were down for this tournament, but hopefully with a date change in 2018 these figures will pick up. The BDLGA Junior Champion for 2017 is Zoe Maxwell (Virginia) with 72 gross. The BDLGA Nett winner was Brittany Else (Rosewood) with 63 nett.

The Divisional Challenge/Champion of Champions tournament was held at Brisbane Golf Club in May. The Champion of Champions number was 12 players with 121 entered into the Divisional Challenge divisions. The Champion of Champions winner was Jess Jenkins (Oxley) with 72 gross.

2017 Junior Jug was held in Cairns with Zoe Maxwell, Brooke Beck and Katerina Marshall making up the team. This team fought hard throughout the event, and came second to Sunshine Coast and Burnett District. It was a bit un-nerving to see warning signs about the crocodiles around the Half Moon Bay Golf Club. The Junior Co-ordinator will present a bigger report on this tournament.

The 4BBB Challenge was held at Windaroo Golf Club in July. We had 45 teams from 17 clubs. Winners on the day came from Riverlakes (Div. 1) and Windaroo (Div. 2). In August we held the Lady Holt Interclub team event at Pacific Golf Club. Again we had a large amount of teams playing on the day - 33 teams from 11clubs. The Lady Holt Perpetual Trophy was won by a team from Brisbane Golf Club. I had the pleasure to attend lunch at Brisbane in September to officially hand over this trophy for it to be displayed in the Brisbane Golf Club trophy cabinet until the 2018 event.

September brought the Meg Nunn Salver to McLeod Country Golf Club hosted by the BDLGA. This was a build-up of 9 months' work by the Management Committee to host this event, and I would like to publicly thank the McLeod Golf Club, their members and fellows and all other staff for the tremendous effort and assistance that we received to host this event. I am still receiving messages of thanks from the other districts on how well this tournament was run. As I have said in previous reports since the Meg Nunn Salver, we enjoyed it so much, that in July we host the next Junior Jug event at Virginia Golf Club.

Country Day was our last official tournament to be held at Laidley Golf Club. We had 19 teams from 11 clubs. This was a great day with Keperra ladies dressing up in country attire. The winning team was Wynnum Golf Club who have this trophy displayed at their golf club for the year.

The Sarah Jane Kenyon Challenge was held at Bribie Island Golf Club, and hosted by the Sunshine Coast and Burnett District. The event is played with 8 juniors from each district, playing single matchplay. The Junior Co-ordinator has included this event in her report.

That should have finished the tournaments for the year, but it didn't. We held the Order of Merit competition all year with players receiving points when they entered the B&D tournaments and extra points for wins and places. The Order of Merit Playoff was held at Oxley Golf Club in November with 103 players qualifying with points to compete in a single stableford competition. The Order of Merit was sponsored by Thailand Golf Tours who generously gave us a golfing trip to Thailand as a raffle draw. Our first Order of Merit winner was Jackie Zuidam from Wynnum Golf Club. Jackie played in all 2017 B&D tournaments, winning once solo and winning in a team event twice. Jackie got 23 OOM points. Second was Alana Griffiths from Keperra, competing in all 2017 B&D tournaments, receiving her 17 OOM points with solo wins and team wins.



On the day Thailand Golf Tours gave prizes for overall winner, runner-up and third place. Overall winner was Di Alroe (Keperra), second was Margaret Emerson (Nudgee) and Maureen McNamara (Wynnum) in third place. The trip to Thailand raffle winner was Jennie Gribble from Keperra. We were extremely pleased that Jennie was present on the day to receive the accolades from everyone in the room.

That should have finished all tournaments for the year – but it didn't!!!! The Women's Gold Coast District have asked the BDLGA to compete in an annual Halcyon Cup tournament starting in 2018. We had the launch for this event in December at Gainsborough Greens Golf Club. The idea was to have equal number of players from both Districts, but Gold Coast had trouble getting their 60 players, so we filled up the spaces with 90 players to 30 from Gold Coast. We had an enormous response to this tournament and I was pleased to use our waiting list to reach our 90 players. All players were extremely lucky to get into the club house at the finish before a storm hit, but the problem was to get to our cars to go home with heavy rain still coming down.

Two lessons learnt this year with our tournaments is "GET YOUR ENTRIES IN QUICKLY". Nearly all tournaments had to be closed before the closing date, due to numbers reaching the field capacity. I made sure that the course was not overloaded, making the day unpleasant for the players having to wait on tees and fairways. Second lesson is – If you want to be in the draw for the Race to Hua Hin raffle draw in 2018 – PLAY IN THE B&D TOURNAMENTS – the more tournaments you play in during the year – the more chances you have in the draw.

During the year we were thankful for the generous support provided by our sponsors: Vanity Fairways, Drummond Golf Woolloongabba, Jane Holt and Family, Thailand Golf Tours, Altitude Financial Group, Tony Hollands Funeral and the BDLGA. We look forward to continued support in 2018. Sponsorship makes our events much more exciting for the players and allows us to keep our low operating costs.

Many thanks to the venue clubs for your support and cooperation before and during our events. A big thank you for your generous morning teas before the start of the tournaments. I have enjoyed working with you and have met new people along the way. These tournaments give us an opportunity to meet your committee and members and hear what these members want from the BDLGA Management Committee.

Thank you to all the Management Committee for your support and assistance with each tournament, leading up to them and on the day. Our BDLGA secretary keeps our website up to date with all the news, tournament dates and also club events, but it is up to the club committees and delegates to keep their members informed. The tournaments can't be successful without your help. Our BDLGA Facebook and Junior Facebook page have been extremely successful with news and photos. It is great to see large numbers of "likes" and "comments" to our stories – it shows that the District Ladies and Juniors are reading our Facebook posts.

77 teams competed in the 2017pPennant season with some very close matches for the final rounds! In 2017 we trialled reversing the playing order from 1/2/3/4/5 to 5/4/3/2/1.....because if it comes down to the last player then by rights it should be your best golfer in that team playing that match....this worked reasonably well for the season except for Divs 7 & 8 when we found that players at position 5 were more nervous at having to tee-off first and this resulted in much slower play......hence we have changed it back to playing in 1/2/3/4/5 order for Divs 6 & 7 for 2018.....all other divisions (1-5) will be in 5/4/3/2/1 playing order.

Looking ahead to the 2018 season we have "tweaked" the GA Handicap ranges so that each division has a GA overlap and it appears that this has made it easier for clubs to field teams. We also have 10 JUNIOR teams for 2018.....the most we have ever had and testament to all the hard work that Clubs, Professional staff and Committees have been doing over the past couple of years to encourage more young females to play in golf.....well done to all!

Again in 2018 we have scheduled the season into two "blocks", Divisions 1-4 from 20th April; Weekend starting earlier and Divisions 5-7 from 8th June. We trialled these two blocks last year and we received positive feedback so we have decided to do the same again in 2018.

The 2018 Season has come together well.....a few "curly" ones this season resulting in a few divisions only having 5 teams....a case of too many for one division and not enough for two! Ideally 7 teams per division is perfect but not always possible.

Pacific were the winners which went to the final day to determine who would take the flag.

The BDLGA Junior Championships were played at Virginia on the 5th April. This event was held in conjunction with Golf Queensland for the Joan Irving Memorial Trophy. 2017 was the last year this was a joint event. The 2017 Junior Gross Champion for 2017 was Zoe Maxwell from Virginia who then was our representative at the Greg Normal Junior Masters. This event was held at the same time as a Golf Queensland event at Pelican Waters so the numbers were down on previous years. In 2018 this event is a BDLGA event and will be held at Virginia on Sunday 22nd April to avoid any clash with any other event. Hopefully the numbers will be better.

The next major event was the Junior Jug which was hosted by North Queensland in Cairns. The team of Zoe Maxwell (Virginia), Brooke Beck (Wynnum) and Katerina Marshall (Nudgee) played exceptionally well in both wet weather and sunny weather. The girls also had to keep their eyes out for the crocodiles that resided around the course. Brisbane came a close second by 1½ points behind our local rivals Sunshine Coast!! Brisbane District is hosting the Junior Jug for 2018 at Virginia. We might have a home course advantage. The team will be announced after the Junior Championships. Thank you to the girls' mums for their caddying duties and helping to keep the girls focussed.

Next was Sarah Jane Kenyon at Bribie Island Golf Course in November. The date of this event was changed so many times but we finally managed to have the event played! Our team of Keely Purdey (Virginia), Mackenie Devine and Chloe Letts (Pacific), Gemma Rigby and Aspen Sugars (McLeod), Georgia Bouwens (Wynnum), Brittany Else (Rosewood) Poppy Harrington (Redland Bay) were beaten by the home team of Sunshine Coast. Brisbane will host this event in 2018 at Redcliffe.

All of the Golf Queensland events throughout 2017 were well supported by girls from the Brisbane District and it is great to see some achieving very good results. Keep up the good work girls.

It is always nice to see all the girls from every district playing the game in the correct spirit and seeing the friendships these girls have made through their golf.

To the girls moving into senior ranks we wish you all the best and it is great to see so many new girls coming through the Junior ranks. Our 10 teams in the 2018 Pennants is evidence of that.

I am pleased to present to you my Treasurer's Report for the Association's financial year.

As has been true for a number of years, our main income source, and busy part of the year for me, is collection of the Capitation Fees on behalf of Golf Queensland and Golf Australia. It is a very strong possibility that this will be the last year that the Association will have to collect these fees from clubs as Golf Queensland is set to take over this function with effect from 2019.

You will note from the Financial Statements that sponsorship income has substantially increased this year and we would like to thank all of our sponsors for their generous support over the year. These sponsors have agreed to come back on board for 2018 and we thank them for that.

Tournament income has risen this financial year and this is due mainly to the increase in the number of players entering the tournaments rather than an increase in the entry fees. We had approximately 100 extra ladies play in competitions in 2017 than in 2016. We do try to keep our costs to members to a minimum and generally only cover the cost of the green fees being charged by the clubs. We also put on an extra day at Oxley Golf Club which was the Race to Hua Hin and these entry fees will be reflected in these figures.

Pennant costs increased slightly during the year due to the purchase of new pennant flags and silver pins where stocks were depleted. The obvious biggest increase from previous years was in Tournament Expenses.

This year saw us hold the Meg Nunn tournament in Brisbane and the bulk of this increase over other years is the need to pay green fees for the week of the event and hosting of the dinners at the start and finish of the week, together with extra accommodation costs for the committee members that were working during the week. Our Junior Jug event was also a little further away than the previous year and we had to incur extra costs in terms of travel and accommodation.

General tournament costs were also up due to the extra day the Association put on in conjunction with Thailand Golf Tours at Oxley Golf Club that was the Race to Hua Hin. The Brisbane and District Association put on the lunch for the players and the sponsors on this day.

2018 promises to be another exciting year so I would encourage you to pass along as much information as you can to your members so that they may come and see where their Affiliation Fees are going. Finally I would like to thank my fellow committee members and club delegates for your support during the year.

I would now like to propose that the 2017 Financial Statements as contained in the Annual Report be accepted.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the committee, as well as evaluating the overall presentation of the annual report.

The financial report has been prepared for distribution to the members for the purpose of fulfilling the committee's financial reporting obligations under the Queensland Associations Incorporation Act 1981. We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Queensland Associations Incorporation Act 1981. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report.

a. Property, Plant & Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciation amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the assets is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

b. Revenue and Other Income

Revenue is measured at the fair value of the consideration received after taking into account any trade discounts and volume rebated allowed. For this purpose, deferred consideration is not discounted to present values when recognizing revenue.

Interest revenue is recognized using the effective interest rate method, which for floating rate financial assets is the rate inherent to the instrument.

Grant and donation income is recognized when the entity obtains control over the funds which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

NOTE 2: ASSETS & LIABILITIES

The only Assets and Liabilities of the association are those shown in the balance sheet. Further the association has no Mortgages, Charges or Securities of any description.


